



Lifetime No Clog Money Back Warranty

Leaf Solution LLC guarantees their gutter guard protection system will not allow the gutters and/or downspouts to ever clog for the life of the gutters and downspouts. Leaf Solution LLC will refund your purchase price and remove the product from the below address if the gutters and/or downspouts are to ever clog.

This Express Warranty is subject to the following conditions and limitations:

- 1) The Leaf Solution LLC product must be installed by an authorized Leaf Solution LLC Dealer. Leaf Solution LLC Dealers are trained in the proper installation of our product. Our warranty is representative of the confidence that we have in the Leaf Solution Gutter Protection that is based on testing and retesting of our product and being able to rely heavily on our trained Leaf Solution LLC distributors to ensure the proper installation. With the extensive testing and ability to effect proper installation, we are able to ensure you, the customer, Leaf Solution's protections.
- 2) The Leaf Solution product, when installed by an authorized dealer in new condition, is warranted against defects for the life of the gutters and downspouts. This warranty is a guarantee from Leaf Solution LLC that your gutters and/or downspouts will not clog from normal tree or leaf debris clogging the interior of your gutters or downspouts. This express warranty is void in the event the Leaf Solution product is intentionally or accidentally damaged, exposed to anything other than normal weather conditions, or altered or subjected to violent weather conditions, fire, fallen tree limbs or other acts of nature. The Leaf Solution product is guaranteed to perform as provided when exposed to normal outside weather conditions and natural tree and leaf debris and sediments.
- 3) Warranty transferable. This warranty is transferable to all subsequent purchasers of the home or dwelling in which the Leaf Solution product was originally installed on. To transfer this warranty to the new owner, simply have the new home owner sign and date a copy of the original warranty and forward to Leaf Solution LLC. Please note that regardless of how many times this warranty is transferred, the total period of warranty is the lifetime of the gutters which is generally 20-40 years.
- 4) In the event that you will be re-roofing your home and the roofer requires the Leaf Solution product to be removed, your Leaf Solution Dealer must be notified so that he or she can come out and uninstall your Leaf Solution and come back when the roofing job is complete to reinstall your Leaf Solution product. Please contact your local dealer/distributor for instruction. (Local dealer/distributor may allow the roofer to replace with an inspection.)
- 5) Leaf Solution LLC and/or an authorized distributor and/or dealer reserves the right to inspect any installation of its product in order to continually serve its customers properly.
- 6) Rainfall can occur in exorbitant amounts and cause your gutter to overflow at times even though there is no clog. The Leaf Solution installer will come back as a free repair call if water is overflowing any part of your gutter under normal rainfall conditions. Leaf Solution LLC reserves the right to charge an inspection fee and trip charge for any repair or warranty issue that is not a direct result of product failure.
- 7) No implied Warranty; Limits of Liability. Unless prohibited by law, Leaf Solution LLC and the Leaf Solution product disclaim all implied warranties of any kind including any warranty of merchantability or fitness for a particular purpose, and also excludes any warranties arising under any version of the Uniform Commercial Code. By having the Leaf Solution product installed on your home or dwelling, you agree that in no event shall Leaf Solution LLC be responsible for any special, incidental, indirect or consequential damage of any kind, or any damages whatsoever arising out of or in connection with the installation or use of the Leaf Solution product. Recovery of any kind including consequential or incidental damages in the event of warranty or product failure is strictly limited to the purchase price of the Leaf Solution product.
- 8) For this warranty to be effective, dealer and homeowner must fill in all information below. Dealer is responsible of providing an executed copy to homeowner, and to keep one on file permanently. If you sell your home, you will need to contact the Leaf Solution Dealer below to transfer the warranty. NOTE TO DEALERS: Warranty Information must be kept on file permanently and filed with local distributor. All warranty claims must be filed with Leaf Solution LLC immediately upon request.
